4. The rate(s) quoted by you for Construction of for pathway & covered shed for newly constructed classrooms should be inclusive of GST. In case GST is chargeable it should be mentioned separately.
5. Your quotation should be valid for a period of 120 days from the date of submission.
6. If your quotation is accepted, supply of the stores and completion will have to be rendered within 02 Weeks from the date of placing of the supply order by this school.
7. **Payment Terms** – The mode of payment as per progress of Construction of for pathway & covered shed for newly constructed classrooms will be made through cheque after inspection of items as per RFP & acceptance of the same by the Board of Officers.

a)	Foundation	15%
b)	Roof level	35%
c)	Finishing of all works	50%

8. Liquidated damages to the sum of 0.5% of the contract price of the delayed/undelivered stores/services mentioned above for every week of delay or part of a week, subject to the maximum value of the liquidated damages being not higher than 10% of the value of delayed stores.

9. **Warranty** - The Following warranty will form part of the contract placed on the successful Bidder

(i) The Seller warrants that the goods supplied under the contract conform to technical specifications prescribed and shall perform according to the said technical specifications.

(ii) The seller warrants comprehensive warranty for a period of Thirty Six (36) Months from the date of acceptance of stores by Joint Receipt Inspection or date of installation and commissioning, whichever is later, that the goods/stores supplied under the contract and each component used in the manufacture thereof shall be free from all types of defects/ failures.

10. **Earnest Money Deposit**. Bidders are required to submit Earnest Money Deposit (EMD) for an amount of Rs. 5,716/- (Rupees Five Thousand Seven Hundred Sixteen only) along with their Bids. The EMD may be submitted in the form of an Account Payee Demand Draft/Banker's Cheque in favour of **Principal, Army Public School Khadakwasla, Pune – 23** or Fixed Deposit Receipt/Bank Guarantee from any of the public sector banks or a private sector bank authorised to conduct government business as per format enclosed as **Appendix 'B'**. EMD is to remain valid for a period of 45 days beyond the final bid validity period. EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. The bid security of the successful bidder would be returned, without any interest whatsoever, after the receipt of performance security from them as called for in the contract. EMD is not required to be submitted by those bidders who are registered for the same item/range of products/goods or services with Central Purchase Organization (e.g. DGS&D), National Small Industries Corporation (NSIC) or any Department of MoD or MoD itself. The term – "Department of MoD or MoD itself would mean either the Ministry of Defence itself or Departments functioning under MoD i.e. Dept. of Defence, Dept of Defence Production, Dept. of Ex-servicemen Welfare, Dept of Defence Research & Development and Defence Finance Only." Firms registered/empanelled at various Defence Establishments at Unit Level and at Service Headquarters level cannot be considered for the purpose of exemption from submitting EMD. The EMD will be forfeited if the bidder withdraws or amends impairs or derogates from the tender in any respect within the validity period of their tender.
